PLACEMENT INSTRUCTIONS



- A** Roll the earplug between your thumb and index finger until you achieve the desired thickness.
- B** Use your other hand to lift up your ear in order to create sufficient room in the ear canal to put the earplug in.
- C** Push the rolled-up earplug into your ear canal using a turning motion and allow it to expand before entering the noisy environment.

It is important to make sure that the earplugs you wear offer a good fit. After using the earplugs, you slowly remove them from your ears using a slight turning motion to prevent damage. **Warning:** Do not use corded earplugs to avoid the risk of the cord getting caught on or entangled in something.

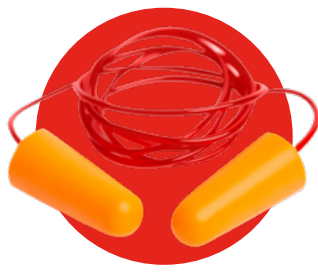
